#### Agenda Items:

**It was brought up that possibly the Little Falls Monday league would try to merge with the Little Falls Wednesday "fun" league. Many items were not finalized until this decision has been made.**

- ⑧ Leagues begin Monday, October 5, 2009 - **HOLD OFF**
- ⑧ Game format is 4 player – 16 game format
- ⑧ Roster deadline is Friday, September 25<sup>th</sup>. Final deadline is December 1, 2009.
  - Available online, player mailing, at the meeting, and sponsor locations. **Complete rosters are needed and email addresses are highly recommended. If email addresses are supplied standing will be emailed out.**
- ⑧ Schedules will be done 1-2 days prior to your start date. Packets will be delivered to your sponsoring locations prior to the first night of play. Captains will be notified by phone where their first night of play is.
- ⑧ Voted to have 1st Monday of deer hunting off. **This would be November 9, 2009 if the league remains on Monday nights.**
- ⑧ Playoffs will play out and complete on a Monday. – **IF THE LEAGUE REMAINS ON MONDAY NIGHTS**
- ⑧ A traveling trophy is awarded to the 1<sup>st</sup> place team for your league, not for your playoff. The winner of the traveling trophy was Red Bull -
- ⑧ *Score sheets should be signed by both team captains after the match, verify the money and **both team captains should keep a carbon copy of the match scores***
- ⑧ **Home team is responsible to Mail day after match.**
- ⑧ Standings are mailed to all sponsoring locations and can be found on the website at [www.mwcoin.com](http://www.mwcoin.com). **Standings will be emailed to any players that supply their email address**
- ⑧ Fees: Secretary Fees will be \$35.00 per team.
- ⑧ Sanction fees are \$11.00 per player for VNEA, local and MOMA state. A player is sanctioned after (1) week of play. Do NOT send in your sanction fees into our office directly, they will be deducted at the end of the league season from your payback check.
- ⑧ **ACS Sanctioning was offered and there will be a vote later in the season after a merger decision.**
- ⑧ Player Fees: **Voted to raise to \$4.00 per player per week regardless of merger decision.**
- ⑧ Payback Money: **Voted to stay as is**
  - 8 Ball Point Payback - 50% of your league funds
  - Playoffs - 50% of your league funds
- ⑧ Start time for league will be 7:30 p.m.
- ⑧ Captains Guides- See Page 15 for Personal Check Policy – **No Personal Checks for Tournament Entry Fees. Ask you Location Sponsor to write one, cash and credit card are also acceptable forms of payment**
- ⑧ **Rack your own will be mandatory this year.**
